

## **Ice-America Code of Conduct**

## Participants and Spectators Responsibility and Assumption of Liability Agreement

- 1. Read and abide by all posted signs and warnings. Cooperate with ice rink staff.
- 2. No dogs or pets of any kind are permitted on the premises. Service animals permitted in accordance with applicable law.
- 3. For your safety, maintain reasonable control of your speed, course, and direction. No weaving through other skaters. No more than two people may skate together. Do not skate in groups. Do not stop where you obstruct other skaters. Skate in the same direction. Do not interfere with other skaters' safety and pleasure. No tag or games of any kind permitted on the ice.
- **4.** Be cautious Maintain a proper lookout to avoid other participants, objects, or conditions on the ice surface. Report any hazards to facility staff.
- 5. Accept responsibility for knowing the range of your ability while on the ice surface; participate within the limits of that ability and as appropriate to the sessions in which you are involved. No figure/fancy skating or backward skating is permitted during public sessions, except when and where designated.
- **6.** When the ice is being resurfaced or serviced, leave the ice. Keep exits clear and do not sit on, lean over, or leave articles on or near the boards. Before entering the ice surface, look for oncoming skaters.
- 7. Any person suspected of being under the influence of alcohol, marijuana, or a controlled substance will not be allowed inside the ice rink and may be asked to leave.
- **8.** Patrons are not permitted to enter onto the ice surface in street shoes or other footwear not specifically designed for ice skating.
- Patrons are not permitted to bring food or drink onto the ice surface or the surrounding boards.
  Management reserves the right to check baggage if deemed appropriate.
- **10.** Hockey or other game equipment is not permitted in the ice rink facility.

- **11.** Do not carry children, backpacks, purses, or other items while skating.
- **12.** Do not act in a manner that may cause or contribute to injury of yourself or any other person.
- **13.** Do not use electronic devices while skating. No eating, drinking, headphones, or phone use on the ice surface.
- **14.** Do not throw or leave objects on the ice surface. Do not throw snow or ice.
- **15.** Do not instigate or become involved in any type of altercation with any other skater or spectator. Fighting or malicious destruction may result in immediate removal.
- 16. Assumption of Risk: As further described in the required Adult & Parental Consent, Release and Waiver of Liability, Indemnification, and Assumption of Risk Agreement to which all participants are subject, by entering the premises, participants and spectators are deemed to have knowledge of and assume the inherent risks of spectating, skating, and other on-ice activities, which include but are not limited to the following:
  - **a.** Injuries that result from collisions or contact with other spectators or participants
  - b. Injuries that result from slips, trips, and falls
  - c. Injuries that involve objects or artificial structures that are properly within the intended path of travel of the participant or spectator
- 17. Failure to comply with the above CODE OF CONDUCT may result in, but is not limited to, ejection from the facility.
- 18. This facility is a smoke- and vape-free environment.
- **19.** We reserve the right to refuse admittance or service to any person.
